Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On August 27, 2012, the agency received a report regarding an 8-month-old child who presented at a local hospital with dried blood in his ears and bruise on the left jaw line of his face. The child's grandmother was awarded guardianship of the child on 8/27/12. After returning home from court with the child, the grandmother noticed the child was not acting like he normally did. The child vomited after taking a bottle and the grandmother observed blood in the vomit. The child was also acting confused when the grandmother attempted to interact with the child. The grandmother took the child to the local hospital for an examination and the child was later transferred to Children's Hospital of Wisconsin for further evaluation. Medical professionals found the following injuries to the child: three separate rib fractures, a complete fracture of the right wrist (healing), a complete fracture of the left wrist, a fracture of the smaller bone in the right lower leg (healing), a complete fracture of the left ankle (both bones), blood in both ears (caused by trauma to the ear canals) and facial bruising. Law enforcement was contacted to investigate the cause of the injuries to the child. The mother has been criminally charged with one count of Child Abuse-Intentionally Cause Great Bodily Harm, one count of Neglecting a Child (Consequence is Bodily Harm), one count of Neglecting a Child, and two counts of Resisting or Obstructing an Officer. The mother's boyfriend has been criminally charged with one count of Child Abuse-Recklessly Cause Great Harm, one count of Neglecting a Child (Consequence is Bodily Harm), and one count of Neglecting a Child. Both the mother and the boyfriend were found guilty of the charges.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency screened in and collaborated with law enforcement and medical professionals to complete the assessment. The agency ultimately substantiated physical abuse and neglect to the child by the mother and the mother's boyfriend. The child had been in the care of the mother and the mother's boyfriend prior to the court hearing which granted guardianship to the grandmother. Medical professionals diagnosed the child with "severe child physical abuse" after sustaining a significant number of fractures throughout his body in different stages of healing. The child also had observable bruising to his face and dried blood in the external auditory canal. Medical professionals determined no underlying health issue/disease existed that contributed to the injuries which lead to the diagnosis of abuse. The multiple fractures in various stages of healing suggest the injuries occurred 5-7 days prior to the medical evaluation based on calcification of the bones. The injuries not in a state of healing would likely have occurred within a few days prior to the medical evaluation.

On 6/19/12, the agency screened in a report alleging neglect to the child by his mother. Neglect was unsubstantiated and the agency closed the case.

The agency collaborated with law enforcement and medical professionals to complete the assessment. The agency substantiated physical abuse and neglect to the child by the mother and the mother's boyfriend. The child continues to reside in the home of his grandmother and determined safe in her care. The family declined an offer of services and the agency has closed the case.
