**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On October 16, 2022, the agency received a report regarding a 1-month-old infant found unresponsive in his home and later pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. Medical professionals noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the mother and the father. Medical professionals noted no signs of trauma to the infant; the autopsy report is pending. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

At the time of the incident, the agency was assessing the September 12, 2022 CPS Report. The last contact by the agency was a home visit with the mother and father on October 14, 2022.

On September 12, 2022, the agency screened-in a CPS report alleging neglect to the infant by the mother. The infant died during the assessment period, and an additional report was made to the agency regarding the infant's death on October 16, 2022. An assessment of the allegation was completed by the agency, and the initial allegation of neglect was unsubstantiated.

On April 4, 2022, the agency screened-in a CPS Report for Alternative Response regarding unborn child abuse. An assessment was completed by the agency with the determination of services not needed. The case was closed upon completion of the Initial Assessment.

On March 28, 2022, the agency screened-in a Services Report. The agency did not refer the family for services.
