A CPS Report was received and screened in on March 15, 2011. The initial assessment was underway when the child was seriously injured on March 26. On March 15, the agency arranged for relatives to care for the child while they were obtaining medical information regarding some markings on the child's face that the doctor attributed to a reaction to medication. On March 16, the child was permitted to return to the mother's home. The agency's last contact prior to the incident was a face-to-face visit with the mother on March 17.

Summary of actions taken by the agency under ch. 48, including any investigation of a report or referrals to services involving the child, any member of the child's family living in this household and the child's parents and alleged maltreater at the age of 18 years or older:

On March 15, 2011, the agency screened in a report alleging physical abuse to the child. The child had what appeared to be

bruises to her face, neck and back. Three doctors concurred that the marks were due to a possible drug reaction and not maltreatment. The allegation of physical abuse was unsubstantiated. During the assessment, the agency received a new report regarding alleged maltreatment resulting in serious injuries to the child.

Summary of any investigation conducted under ch. 48 or ch. 938 and any services provided to the family since the date of the incident:

The agency screened in the report of serious injuries to the child, substantiating physical abuse to the child by the mother's boyfriend. The explanations provided by the boyfriend do not match the child's injuries which doctors indicate were caused by non-accidental blunt force trauma. The agency assisted the family with arranging for needed care for the child upon release from the hospital. The child is in the custody of her mother and will receive in-home care from the mother and relatives. She will also continue to receive medical care. The case remains open for Ongoing Services case management.

* Summary of actions taken by agency in response to the incident:

The agency screened in and investigated the report of alleged physical abuse. Physical abuse to the child by the mother's boyfriend was substantiated, and the child was determined unsafe. The agency took temporary physical custody of the child, later returning custody to the mother. The agency collaborated with law enforcement and medical professionals during the investigation. The agency worked with the family to arrange in-home care with relatives with whom the mother and child are residing. The case remains open, and the family continues to receive Ongoing Services case management from the agency.

*Summary of policy or practice changes to address identified issues:

The initial assessment is not in compliance with the CPS Access and Initial Assessment Standards and the CPS Safety Intervention Standards. The DSP is working with the agency to address identified issues.
