Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On November 2, 2017, the agency received a report regarding a 6-month-old infant brought to the hospital with burns. Medical professionals who examined the infant suspected submersion in scalding water due to the infant's presenting symptoms. The infant was transported to another hospital where she passed away five days later. Law enforcement was contacted and initiated a criminal investigation. As a result of law enforcement's investigation, the father was arrested and charged with Neglect-Causing Death. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect to the infant by the infant's father. Preliminary findings by the Medical Examiner's Office indicate that the infant suffered burns that contributed to her death. The final determination of manner of death is pending. The infant's 5-year-old sibling was deemed safe and remained with his biological father. The agency closed the case upon completion of the Initial Assessment.
