On March 23, 2018, the agency received a report regarding 5-year-old child pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner noted no known anatomical cause for death. Toxicology results indicated the absence of needed medication. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the child, his 1-year-old sister, and his 2-year-old brother by the mother. The agency found a preponderance of the evidence to substantiate maltreatment of neglect to the child by the mother's significant other. The Medical Examiner noted no known anatomical cause for death. Toxicology results indicated the absence of needed medication. The 1-year-old and 2-year-old siblings were deemed unsafe, taken into Temporary Physical Custody, and placed in a licensed foster home. On April 10, 2018, a Child in Need of Protection or Services Petition was filed on behalf of the siblings and the case remained open to provide ongoing case management services.
