Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

One February 16, 2020, the agency received a report regarding a 4-year-old child and 5-year-old child who were found deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the deaths to be non-accidental; toxicology results are pending. As a result of law enforcement's investigation, the mother's boyfriend, who was also the father of the 5-year-old child, was criminally charged with First-Degree Intentional Homicide. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the 4-year-old child and the 5-year-old child by the mother's boyfriend, who was also the father of the 5-year-old child. The Initial Assessment also found insufficient evidence to substantiate neglect of the 4-year-old child and the 5-year-old child by the mother's boyfriend, who was also the father of the 5-year-old child. The Medical Examiner's Office determined the deaths to be non-accidental. The agency closed the case upon completion of the Initial Assessment and no service referrals were made.
