**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On June 16, 2022, the agency received a report regarding a 2-year-old child pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's office noted no signs of trauma to the child; toxicology results are pending. No criminal charges were filed, and the case was closed.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate maltreatment of neglect by the aunt. The Medical Examiner's office noted no signs of trauma to the child; toxicology results are pending. The agency determined the child's siblings and other children in the home safe, and they remained with their aunt. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

The agency determined the child's siblings and other children in the home safe, and they remained with the relative caregiver. The agency closed the case upon completion of the Initial Assessment and no service referrals were made.
