Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On August 16, 2022, the agency received a report regarding a 3-year-old child who was brought to the hospital and pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the final autopsy report is pending. No criminal charges were filed, and the case was closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the mother and the mother's partner. The Medical Examiner's Office noted no signs of trauma to the infant; the final autopsy report is pending. The agency determined the child's siblings safe, and they remained with the mother and the mother's partner. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
