Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On October 2, 2022, the agency received a report regarding a 1-year-old infant found unresponsive in her home. The infant was taken to the hospital and later pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the infant died as a result of ingesting a controlled substance. As a result of law enforcement's investigation, the mother and father were criminally charged with Neglecting a Child (Consequence is Death) and Party to a Crime. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by her mother and her father. The Medical Examiner's Office determined the infant died as a result of ingesting a controlled substance. The infant's sibling was deemed unsafe, and a Protective Plan was initiated. Subsequently, the Protective Plan was terminated, and the infant's sibling was taken into Temporary Physical Custody and placed with a relative. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
