**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On February 12, 2023, the agency received a report regarding a 3-month-old infant found unresponsive in the home. The infant was taken to the hospital where she was pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office made a preliminary determination indicating the death was due to positional asphyxiation; the autopsy report is pending. No criminal charges have been filed, and the case was closed.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the father. The Medical Examiner's Office made a preliminary determination indicating the death was due to positional asphyxiation; the autopsy report is pending. The agency deemed the infant's siblings safe, and they remained with the father. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
