**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On February 24, 2023, the agency received a report regarding a 15-year-old child brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals noted signs of trauma to the child. No criminal charges have been filed in this case, and the investigation was closed.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the child by unknown staff at the facility where the child was residing. The Initial Assessment completed by the agency found insufficient evidence to substantiate maltreatment of physical abuse to the child by unknown staff at the facility where the child was residing. Medical professionals noted signs of trauma to the child. The agency assessed the child's mother and father as protective, and he remained in their care. The agency closed the case upon completion of the Initial Assessment.

**Description of the OHC placement and basis for decision to place child there:**

At the time of the incident, the child was residing in a licensed residential facility. The child had been residing at the facility since October 22, 2018, through an out-of-state placement under the Interstate Compact on the Placement of Children (ICPC) to improve independence and coping skills across multiple settings.

**Description of all other persons residing in the OHC placement home:**

At the time of the incident, the child resided in a congregate care facility that is licensed for 99 children. At the time of the incident, 17 children were residing in the facility.

**Licensing history:** Including type of license, duration of license, summary of any violations by licensee or an employee of licensee or other actions that constitute a substantial failure to protect and promote the welfare of a child.

The facility has maintained a Residential Care Center license since 2001. In 2012, the facility had a violation that constituted a substantial failure to protect and promote the welfare of a child, involving a child being physically abused by a staff member. A plan of correction was subsequently implemented.
