On June 2, 2023, the agency received a report regarding a 15-year-old child brought to the hospital and pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner Office's preliminary determination indicated the child died as a result of complications from an existing medical condition; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner Office's preliminary determination indicated the child died as a result of complications from an existing medical condition; the autopsy report is pending. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the child's father and step-mother. The agency determined the child's step-siblings and half-siblings safe, and they remained in the home with the child's father and stepmother. The agency closed the case upon completion of the Initial Assessment.
