**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On July 4, 2023, the agency received a report regarding a 5-month-old infant pronounced deceased in her home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the death was due to an unsafe sleep environment. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office determined the death was due to an unsafe sleep environment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother. The agency deemed the infant's half-siblings safe, and they remained with the mother. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
