#### CALL TO ORDER AND APPROVAL OF MINUTES

Both summaries highlighted items that connect to the early care and education field and the importance of agency collaboration to support Wisconsin's youngest citizens.

#### NEW BUSINESS: OVERVIEW OF EARLY CARE AND EDUCATION INITIATIVES

Division of Early Care and Education Administrator, Erin Arango-Escalante, and Assistant State Superintendent Sheila J. Briggs provided information related to the Birth-5 Early Childhood State System and its connection to the mission/focus of the ECAC Council. Information shared related to the importance of equity, the Preschool Development Grant, the Wisconsin Infant Toddler Policy Project, and proposed budget items related to the Child Care Strong initiative, early childhood special education and full-time membership aid for full day 4K.

NEW BUSINESS: ECAC MEMBERSHIP

Information was shared with Council members to clarify the roles of Council members and non-members. Council members will act as a lead for any potential ECAC workgroups and non-members will be invited to participate as content experts. A public comment period will be added to all future ECAC Council meeting agendas to allow for non-member participation.
