Qhov nyiaj pab rau kev saws me nyuam txhua lub hlis yuav tsum yog tag nrho \$ \_\_\_\_\_ hauv ib lub hlis.

Qhov nyiaj pab rau kev saws me nyuam txhua lub hlis no yog muab raws li qhov cov kev pab xav tau ntawm tus me nyuam thiab cov xwm txheej kev nyob noj ntawm tus (cov) niam txiv saws thiab tau txiav txim pom zoo ua ke los ntawm tus (cov) niam txiv saws thiab chav hauj lwm (department). Qhov nyiaj pab rau kev saws me nyuam yuav tsum tsis pub dhau qhov them rau kev saib xyuas me nyuam txuas ntxiv tas li (foster care maintenance payment) rau tus me nyuam saws yog nws nyob hauv tus niam qhuav txiv qhuav lub tsev (foster home) hauv xeev Wisconsin. Cov kev hloov kho cov nyiaj muab rau kev saws me nyuam txhua hli yuav tsum ua nrog kev pom zoo ua ke ntawm tus (cov) niam txiv saws raws li cov kev pab xav tau ntawm tus me nyuam, los sis cov kev hloov pauv ntawm qhov muab tau siab kawg hauv ib lub hlis pab rau kev saws me nyuam. Cov ntaub ntawm ntawm cov kev hloov pauv hauv tus me nyuam saws cov kev pab xav tau los sis tsev neeg li xwm txheej kev nyob noj yuav tsum tau muaj. Yog chav hauj lwm (department) tau txiav txim tias tau them nyiaj tshaj rau tus (cov) niam txiv saws tus me nyuam lawm, chav hauj lwm (department) yuav tsum muaj cai mus sau cov nyiaj uas them tshaj lawm uas yog ua raws li lus pom zoo ua ke nrog tus (cov) niam txiv saws. Yog tias txoj kev sau li no tsis tau txiaj ntsim dab tsi, chav hauj lwm (department) yuav tsum muaj cai nrhiav lwm cov hauv kev los mus sau cov nyiaj.

B. Kev Kho Mob

1. Cov kev pab kev kho mob muab raws li Title XIX of the Social Security Act (Medicaid) yuav muaj rau tus me nyuam saws raws li cov txheej txheem ntawm lub xeev uas tus me nyuam saws nyob hauv. Cov kev pab muab los ntawm Medicaid yuav txawv ib lub xeev rau ib lub xeev thiab yuav muaj pauv raws li tsoom fwv thiab lub xeev txoj cai. Yog tias tus me nyuam saws tsis muaj cai tau txais Medicaid hauv lub xeev nws nyob, Wisconsin yuav muab Medicaid rau.
2. Medicaid muab kev pab thaum lwm qhov chaw pov hwm kev mob nkeeg tsis them rau cov kev pab. Cov ntaub ntawm kew hloov pauv hauv kev noj qab haus huv thiab lwm yam kev pov hwm yuav tau muaj.

C. Kev Saws Me Nyuam Cov Kev Siv Tsis Muaj Tshwm Sim Ntxiv

Chav hauj lwm (department) pom zoo them nyiaj rau tus (cov) niam txiv saws rau cov kev siv uas muaj laj thawj thiab tsim nyog kom txoj kev saws me nyuam tshwm sim, uas ntau siab kawg yog \$2,000. Cov kev siv nyiaj yuav tsum: 1) cuam tshuan ncaj qha rau txoj kev saws raws cai; 2) tsis yuam txoj cai lij choj ntawm lub xeev los sis tsoom fwv; thiab 3) tsis tau txais kev pab them los ntawm lwm pob peev nyiaj. Kev them nyiaj tsuas yog thov tau tom qab ua tiav kev saws me nyuam nkaus xwb. Daim ntaww thov them nyiaj yuav tsum xa tuaj nyob hauv ob lub xyoos tom qab hnub ua tiav kev saws me nyuam.

D. Cov Kev Pab Rau Tib Neeg Lub Neej

Cov kev pab rau tib neeg lub neej muab raws li Title XIX of the Social Security Act yuav muaj rau tus me nyuam saws raws li cov txheej txheem ntawm lub xeev uas tus me nyuam saws nyob rau hauv.

E. Rhais Chaw Tawm-Ntawm-Lub Xeev Mus

Tus (cov) niam txiv saws yuav tsum ceeb toom rau chav hauj lwm (department) paub txog lawv qhov chaw nyob tshiab. Ib qho kev pab twg rau kev saws me nyuam txhua hli yuav muab mus ntxiv los ntawm State of Wisconsin. Chav hauj lwm (department) yuav xa tus me nyuam saws mus rau lub xeev nyob tshiab kom muaj cai tau txais Medicaid under Title XIX of the Social Security Act. Cov kev ntshaw xav tau ntawm tus me nyuam saws raug pov thaiv los ntawm Interstate Compact on Adoption and Medical Assistance. Yog tias ib qhov kev pab xav tau tshwj xeeb uas tau muab teev rau hauv daim ntawm cog lus tsis muaj nyob rau hauv lub xeev tshiab los sis hauv cheeb tsam chaw muab kev pab mus nyob rau hauv, State of Wisconsin muaj lub luag hauj lwm pab fab nyiaj txiag rau qhov (cov) kev pab tshwj xeeb uas tau teev tseg thaum daim ntaww cog lus pab rau kev saws me nyuam tseem siv tau.

- B. Ib xyoos ob zaug, chav hauj lwm (department) yuav tsum xa ntaww ceeb toom rau tus (cov) niam txiv saws kom paub txog cov luag hauj lwm tom qab saws me nyuam uas muab teev meej rau hauv II.A. Ntaww ceeb toom yuav tsum suav cov yim neeg uas tau rhais chaw tawm hauv lub xeev mus lawm.
- C. Chav hauj lwm (department) yuav tsum xa ntaww ceeb toom rau tus (cov) niam txiv saws kom paub txog cov kev hloov pauv kev pab rau kev saws me nyuam los sis lwm txoj hauj lwm uas yuav tsum tau nqes tes ua raws li lub xeev los sis tsoom fwv cov kev cai hloov pauv.

### **III. Tsum Tsis Ua Mus Ntxiv Lawm**

  1. Kev pab rau kev saws me nyuam yuav muab mus ntxiv kom txog thaum hnub nyog 19 xyoos yog tias tus me nyuam saws kawm ntawv puv ib hnub nyob hauv tsev kawm theem siab (high school) los sis hauv ib qhov kev kawm zoo ib yam li ntawd.
  2. Kev pab rau kev saws me nyuam kuj yuav muab mus ntxiv kom txog thaum hnub nyog 21 xyoos yog tias ua tau raws li **txhua yam** no: a) tus me nyuam saws kawm ntawv puv ib hnub nyob hauv tsev kawm theem siab (high school) los sis hauv ib qhov kev kawm zoo ib yam li ntawd; b) chav hauj lwm (department) txiav txim tias tus me nyuam saws muaj kev puas hlwb los sis puas cev uas yuav tau pab mus ntxiv raws li 42 USC 673; c) tus me nyuam saws tsis muaj feem tau txais lwm cov kev pab (piv txwv li, SSI, SSA, VA); thiab, d) tus me nyuam saws tsis tau kev pab txaus mus kawm txuas ntxiv hauv tsev kawm theem siab los sis hauv ib qhov kev kawm zoo ib yam li ntawd.
