Division of Milwaukee Child Protective Services



Serving Families in Milwaukee County

The following services are within the legal jurisdiction of the Division of Milwaukee Child Protective Services (DMCPS). Some are provided directly by DMCPS; others are contracted to the agencies listed. Child welfare services are initiated to provide the immediate protection of children.

Access

Division of Milwaukee Child Protective Services
This unit takes referrals on cases of alleged child abuse/neglect from the public. The (414) 220-SAFE line is answered 24 hours, every day. Access workers screen calls to determine if the report meets the state standards of abuse or neglect. Those reports screened in for a safety assessment are assigned a response time before forwarding the case to the Initial Assessment unit.

Initial Assessment

Division of Milwaukee Child Protective Services
Initial Assessment staff conduct a safety assessment of the child during a visit at the child's school, home, or other location. They also determine if the alleged maltreatment has occurred. The Initial Assessment specialist interviews the family and others involved with the child to get a complete picture of family functioning and identify current and impending dangers. Services to ensure the safety of the child will be put into place in the home if the child is found to be unsafe. If the parent cannot or will not control for safety, the child may be taken into temporary physical custody.



Case Assignment & Placement

Professional Services Group

When DMCPS determines that a family needs help to keep children safe, a case is transferred from Initial Assessment to the assigned Case Management agency. The Placement Unit assigns the case to a partner agency. If the child is going to be placed in out-of-home care, the Placement Unit also provides the agency with the needs of the child or sibling group so that a suitable foster family can be located. If the child is to be placed with relatives, which is preferred, background checks will be done to ensure the relative's home is a safe place for the child. A relative search will also be done so relatives can be notified that the child has come into care.

Case Management: In-Home Services

Children's Wisconsin & Wellpoint Care Network

In-Home Services are provided when a safety threat is identified but the assessment determines the children can remain in the home with services in place to address the safety issues. DMCPS' partners collaborate with families to provide services and supports to address issues that may put the child at risk. An In-Home Services Case Manager regularly visits the home to work with the family.

Case Management: Ongoing Services

Children's Wisconsin & Wellpoint Care Network

When a child's safety cannot be maintained in the home, court intervention is sought to place the child in out-of-home care. These cases are monitored by Case Managers who ensure the family has regular visits with their children and the services and supports they need to work towards reunification. The Case Manager also supports the out-of-home care placement to ensure the needs of the child are met. Post reunification services are offered to families for up to one year after the court case closes. If reunification cannot be achieved, the Case Manager works to identify other permanency options for the child.

Staff Development and Foster Parent Training

Milwaukee Child Welfare Partnership for Professional Development – Helen Bader School of Social Welfare

The Helen Bader School of Social Welfare at the University of Wisconsin–Milwaukee partners with DMCPS to provide both staff development and foster parent training.

Milwaukee Family Intervention Services (MFIS)

Community Advocates

MFIS serves caregivers (biological parents, legal guardians or other adults providing care for the youth) and youth (aged 10-17), living in Milwaukee County, who are experiencing behavioral concerns, truancy issues, academic related problems, runaway behavior, and other conflicts between the caregiver and child.

Kinship Care

Professional Services Group (PSG)

Families caring for children of relatives may be eligible to receive financial assistance. Kinship Care representatives visit the home to learn why the child is not living with the parent and identify services needed. DMCPS and PSG administer the program in Milwaukee County.

Independent Living

Children's Wisconsin & Wellpoint Care Network

Youth ages 14 and older who have been in court-ordered out-of-home care for a minimum of six months are eligible for independent living services as part of Case Management. Services are youth-driven and ensure youth can live independently. When a youth exits out-of-home care after 18 or in another qualifying way, they are eligible to receive voluntary programming through Transitional Resource Agencies (TRA) who provides support with housing, education, employment, health, and caring connections. Qualifying youth are eligible for TRA until the age of 23.
