Definitions

Automated Rating: A provider who does not wish to have any Training or Technical Assistance and does not want a Technical Consultant to come visit their program could receive an Automated rating based upon accreditation and educational qualifications, verified by The Registry (www.the-registry.org). Programs that wish to earn star ratings higher than a 2 Star, must participate in The Registry. Programs can earn 2 Stars if the program is not accredited or 4 or 5 Stars if the program is accredited.

Technical Rating: a process of rating a provider using the YoungStar quality indicators over the course of several on-site visits.

Formal Rating: a rating that is delivered utilizing a combination of YoungStar quality indicators and
